- **High School Students**

- Official high school transcript(s) indicating graduation date: Request that your high school forward your official transcript to the Office of Admissions.
- Applicants who have completed the General Education Development exam (GED) must forward a copy of their scores to the Office of Admissions.
- Official ACT/SAT score(s). The SAT registration code is 2579 and the ACT registration code is 3643.

- **Transfer Students**

- Official college transcript(s) from each college attended.
- Official high school transcript and ACT/SAT score(s) are required unless you have a 2-year associates degree.

Readmission Applicants *(returning student)*

A \$25 application fee, official college transcript(s) from each college attended, and a letter of explanation detailing reason for break in attendance. Readmission will be reviewed before acceptance.

International Students

A \$25 application fee, official secondary school or college post-secondary transcript(s), official bank statement indicating sufficient funds in U.S. dollars to cover UVF's estimate of expenses, signed Student Financial Support Statement and official SAT, or TOEFL score report. All credentials must be received and approved before acceptance can be granted and an I-20 issued.

UNIVERSITY OF VALLEY FORGE COMMUNITY LIFE COVENANT

The University of Valley Forge is a Christian community growing and developing in the four competencies patterned after the description of Jesus found in Luke 2:52: "And Jesus grew in wisdom and stature, and in favor with God and man." The university creates an educationally purposeful environment that encourages students to grow intellectually, physically, spiritually, and socially, while cultivating six core values:

- We believe in God
- We prepare for the future
- We care for others
- We embrace community
- We affirm the dignity of all people
- We serve with creativity and excellence

With this spiritual foundation and these values, all members of the college community, including students, faculty, staff, administrators and all others that share or participate regularly in the life of the University, are expected to comply with these lifestyle standards:

1. Community life at the University of Valley Forge should be marked by a careful, consistent demonstration of Christian love and service to others. Respect for the worth and dignity of each individual regardless of any differences is a foundational tenet of the Christian community of faith. The university does not allow and will not condone discrimination or harassment of another person because of race, color, national or ethnic origin, religious background, age, gender or disability. Bias in any form is never tolerated within the University of Valley Forge community.
2. Community life at the University of Valley Forge should be marked by nurture and instruction in the truths of God's Word. Corporate worship aids in community building and support of the body of Christ. We gather as a community five days a week for required Chapel. Personal devotions and local church involvement are encouraged.
3. Community life at the University of Valley Forge should be marked by attitudes and behaviors that are consistent with a Christian lifestyle. (Reference Galatians 5:19-21, I Corinthians 6:9-10)
4. Community life at the University of Valley Forge should be marked by restraint and discretion in choice of dress and participation in all forms of entertainment. Our standard of dress and choice of entertainment should exemplify our obedience to Scripture that we be modest in all things, that we do not offend in any way and that we glorify God in everything.
5. Community life at the University of Valley Forge should be marked by respect and preservation for our physical and mental well-being. Therefore, the use of alcohol, illegal drugs, tobacco in any form and the abuse of prescriptions and over-the-counter drugs violates our community standard.

In keeping with the distinctive nature of the community, the University of Valley Forge has established this Community Life Covenant. Members of the University of Valley Forge community are expected to abide by the lifestyle standards of this Covenant both on and off campus, and both during the academic term and when the university is not in session. The university reserves the right to confront and address other behaviors that are viewed as dangerous, destructive, unbiblical or inconsistent with the University of Valley Forge mission or principles of Christian community.

The university stands firm in its commitment to be consistent with the values, habits and attitudes of Scripture. The University of Valley Forge is committed to fostering a safe and Christian community.
